CITIZEN COMMENTS/PRESENTATIONS

President McCombie asked the audience if there were any questions or comments for the Board.

A resident from The Regency commented on all the trash along Bartlett and Mundhank Roads. Staff will call the County to see what can be done. Trustee Patel noted that residents should report any vehicles that they see dumping trash in the Village.

A concerned resident from South Barrington Lakes asked the Board by whom Home Owner Associations are regulated to ensure what they do is right. President McCombie said that the HOAs regulate themselves, unless they are doing something that is against Village ordinances. The resident listed his disappointment with his HOA Board over actions and votes by the HOA, especially versus what is listed on their agenda. The resident said that the HOA voted to spend \$10,000 on engineering plans for a curb project after recently announcing that the homeowner ballots to do the project have been coming in with mostly 'No' votes. And one Board member suggested using lake funds to partially pay for the curb project. The HOA also raised dues after erroneously stating there had been no dues increase in recent years.

President McCombie asked the audience if there were any other questions or comments for the Board; there were none.

PRESIDENT'S REPORT

President McCombie recapped a recent trip to Washington, D.C. for intergovernmental workshops. The Illinois Municipal League organized the very educational trip on Federal and Municipal levels working together, and President McCombie brought back valuable contact information for the Village.

President McCombie updated the Board on today's meeting of the Northwest Water Planning Alliance. They will be applying for funds from the Department of Natural Resources for monitoring water levels, which could help reduce BACOG fees.

Trustee Guranovich asked about cooperation from the other agencies; Chief Roman said that the cooperation from other departments has been great.
