#### CITIZEN COMMENTS/PRESENTATIONS

Scott Troeger, Willow Creek Church, and Todd Shaffer, Haeger Engineering, updated the Board on new projects at Willow Creek Church. In June, their new Care Center assisted more than 5000 families. Care Center services now include dental, optometry, and children's clothing. Willow Creek recently appeared before the Village's Architectural Control Commission and received approval for a new monument sign along Barrington Road; it will match the sign on Algonquin Road. They are also building a carport to cover the shuttle buses that they use to facilitate remote parking. They are expanding parking in their southwest lot, and slightly changing the interior roadway. They plan to pave the current construction access road and use it for Sunday traffic as an exit-only. They thanked the Board for the Village's support and asked for questions. Brief discussion ensued on the road work.

President McCombie asked if anyone else in the audience wanted to address the Board. Resident Mike Pirano asked for an update on The Ponds subdivision storm sewer outlet maintenance. The work presently is waiting on permission from IDOT. Mr. Pirano asked the Board to express urgency of the situation to IDOT, as he said the area is in jeopardy of flooding if we receive another heavy rain.

Assistant State Attorney Dave Williams addressed the Board to explain the Regional Organized Crime (ROC) task force program and its relationship with the Village. Discussion ensued. ROC is presently applying for grant money, but Cook County does not have enough meetings scheduled before the grant money deadline, so they would like to go through South Barrington. Mr. Williams explained that there would be no cost to South Barrington because the Village's initial funding for workshops would then be paid back by the grant money. Detective Bryant Haniszewski explained that by combining offenses across the area, it allows him to charge criminals with a Class One level felony, which both increases the jail time and discourages criminals from working in the Village that supports this program. When asked about the program, Chief Deegan said that it is a phenomenal organization.
