5 Call to Order

6 The meeting was called to order by Chairperson Carse at 7:10 pm.  
7

8 Roll Call

9 Present: Chairperson Dr. Shireesha Carse, Commissioner Ken Michonski, and Commissioner  
10 Neal Patel. A quorum was present.  
11

12 Approval of Minutes

13 Commissioner Michonski motioned to accept the minutes of the September 23, 2014 meeting as  
14 written. Seconded by Commissioner Patel; the motion carried by voice vote.  
15

16 Commissioner Michonski motioned to move into Executive Session at 7:12 pm; Commissioner  
17 Patel seconded. Roll call taken. Present: Chairman Dr. Shireesha Carse, Commissioner Ken  
18 Michonski, and Commissioner Neal Patel.

20 The commissioners interviewed Part-time Officer Applicant #3.  
21

22 Commissioner Michonski motioned to move out of Executive Session. Commissioner Patel  
23 seconded. The Commission moved back into regular session at 8:35 pm.

25 Commissioner Michonski motioned to recommend to the Village President that Part-time Officer  
26 Applicant #3 be considered for employment as a part-time police officer. Seconded by  
27 Commissioner Patel; the motion carried by voice vote.

29 Old Business

31 Commissioners discussed the background checks on each of the remaining part-time officer  
32 candidates and concurred with the following:

34 Applicant #7 failed the written test.  
35

36 Applicants #4 and #5 are no longer certified by the Illinois Law Enforcement Training Board.  
37 Both are disqualified.

39 Applicant #2 was previously disqualified by the Commission at an earlier testing and interview  
40 process and, per the Rules and Regulations, may not reapply for two years.  
41

42 Applicant #6 is disqualified based on the results of his background check.  
43

44 Commission Patel motioned, and Commissioner Michonski seconded, to send letters of rejection  
45 to applicants #2, #4, #5, #6, and #7. Motion carried by voice vote.  
46

47 New Business

48 Commissioners reviewed the list of applicants for the full-time police officer position. The  
49 application deadline was November 18, 2014. Over 100 applications were received. Applications  
50 will be carefully reviewed to assure that complete packets were submitted and that they meet the

51 minimum requirements. Successful applicants will be invited to take the written exam on  
52 December 3, 2014.
