6 Call to Order

7 The meeting was called to order by Chairperson Carse at 7:10 pm.

9 Roll Call

10 Present: Chairperson Dr. Shireesha Carse, Commissioner Ken Michonski, Commissioner Neal  
11 Patel and Police Chief Tom Roman. A quorum was present.

13 Approval of Minutes

14 Commissioner Michonski motioned to accept the minutes of the November 19, 2014 meeting as  
15 written. Seconded by Commissioner Patel; the motion carried by voice vote.

17 Police Officer Applicant Orientation

18 Dr. Carse introduced herself and welcomed police officer applicants. There were 68 applicants  
19 present. She turned the floor over to Chief Roman who made a PowerPoint presentation  
20 familiarizing applicants with the Village of South Barrington, the police department, and our  
21 expectations of police officers.

23 Police Officer Written Exam

24 Dr. Carse administered the written exam to police officer applicants. All three commissioners  
25 proctored the test. The test concluded at 9:03 pm and applicants left.

27 Commissioner Michonski motioned to move into Executive Session at 9:05pm for the purpose of  
28 grading the written test. Seconded by Commissioner Patel, the motion carried.

29 Roll call was taken. Chairperson Dr. Shireesha Carse, Commissioner Ken Michonski,  
30 Commissioner Neal Patel, Police Chief Tom Roman and Recording Secretary Mary  
31 Lampugnano were present.

33 Commissioner Patel motioned to move from Executive Session back into Regular Session at  
34 10:35 pm. Seconded by Commissioner Michonski, the motion carried by voice vote.
