1. <u>Discussion Regarding amendment to the Village Code regarding permits for roofing:</u>

MOTION made by Trustee Patel to forward to Village Attorney to create an ordinance with appropriate zoning classification for medical marijuana sales and gaming/gambling activities.

SECONDED by Trustee Stagno MOTION PASSED by unanimous voice vote.
