 NOTICE IS HEREBY GIVEN that the Plan Commission of  
 the Village of South Barrington, Illinois, will hold a public  
 hearing on March 14, 2017, at the South Barrington Village  
 Hall, 30 South Barrington Road, South Barrington, Illinois  
 60010 commencing at 7:30 p.m. to consider, make recom-  
 mendations and conduct a public hearing as required by  
 the applicable statutes of the State of Illinois and the Vil-  
 lage Code of the Village of South Barrington regarding pro-  
 posed text amendments to Chapter 10 of the Zoning Regula-  
 tions of the Village Code of South Barrington to prohibit  
 electronic signs in the Village of South Barrington and to  
 modify the duration of temporary signs to a period not to  
 exceed thirty (30) days.  
 The applicant of the proposed text amendment is the Vil-  
 lage of South Barrington. Copies of the petition to amend  
 Chapter 10 of the Zoning Ordinance will be on file with the  
 Village Clerk and may be inspected during business hours.  
 All persons present at the public hearing will be afforded  
 an opportunity to be heard. Written comments may be sub-  
 mitted to the attention of the Plan Commission Chairper-  
 son, c/o South Barrington Village Hall, at the address afore-  
 said and will be considered if received at least five (5) days  
 prior to the hearing. The Plan Commission reserves the  
 right to continue the public hearing from time to time in ac-  
 cordance with the requirements of the Illinois Open Meet-  
 ings Act.  
 Individuals with disabilities who plan to attend the hearing  
 and require certain accommodations in order to allow  
 them to observe or participate or who have questions re-  
 garding the accessibility of the meeting or facilities are re-
