Notice is hereby given that the Plan Commission of the Village of South Barrington, Cook County, Illinois, will conduct a public hearing on May 24, 2017, at the South Barrington Village Hall, 30 South Barrington Road, South Barrington, Illinois 60010 commencing at 7:30 p.m., or as soon thereafter as the matter is reached on the agenda, to consider, make recommendations, and conduct a public hearing as required by the applicable Statutes of the State of Illinois and the Zoning Ordinance of the Village of South Barrington regarding a modification to a previously approved Planned Unit Development within the Arboretum of South Barrington shopping center to revise the Site Plan, as amended (Site Plan 68), Pad C, to allow for the construction of two buildings in place of one building with additional parking.

The applicant for the amendment to the planned unit development within the Arboretum of South Barrington Shopping Center is the owner of the property, ABT Owner 1, L.P., c/o The Arboretum of South Barrington, 100 West Higgins Road, Suite H-72, South Barrington, IL 60010.

The Plan Commission reserves the right to continue the public hearing from time to time in accordance with the requirements of the Illinois Open Meetings Act.
