NOTICE IS HEREBY GIVEN that the Plan Commission of the Village of South Barrington, Illinois, will hold a public hearing on June 15, 2017, at the South Barrington Village Hall, 30 South Barrington Road, South Barrington, Illinois 60011 commencing at 7:30 p.m., or as soon thereafter as the matter is reached on the agenda, to consider the request to amend a special use for the South Barrington Park District to allow for two additional exterior lighted paddle tennis courts, located at the property commonly known as Three Tennis Club Lane, South Barrington, Illinois.

The applicant is the South Barrington Park District. Copies of the petition and other supporting materials will be on file with the Village Clerk and may be inspected during business hours.

All persons present at the public hearing will be afforded an opportunity to be heard. Written comments may be submitted to the attention of the Plan Commission Chairperson, c/o South Barrington Village Hall at the address aforesaid and will be considered if received at least five (5) days prior to the hearing. The Plan Commission reserves the right to continue the public hearing from time to time in accordance with the requirements of the Illinois Open Meetings Act.
