26 ACADIA DRIVE, SOUTH BARRINGTON

At-Grade Spa

Mr. John Gurdo of 26 Acadia Drive reviewed their submission for an at-grade spa on the property located 26 Acadia Drive in South Barrington. The Commissioners discussed the lack of a landscaping plan. Building Officer Moreland stated that the permit would be contingent on the submittal of a landscape plan and Architect Rafferty's approval. Signage - Spirit Halloween

Linda Stoots, representative of Spirit Halloween, review their submission for temporary signage for Spirit Halloween to be located at the former CVS Pharmacy location at The Arboretum of South Barrington. The Commissioners discussed the dimension of the building and the size of the sign near the front

Building Officer Moreland would check on the dimension of the front facing side to confirm that the sign is in compliance with the Village Code. ENCORE MEMORY CARE AT SOUTH BARRINGTON Signage

Mr. Roth Weaver and Ms. Eileen Scerbicke reviewed their submission for permanent sign face replacement. Mr. Weaver explained that the former Revere Court Memory Care was bought out by Encore Memory Care. They continued and explained that they were unaware of the Village Code that required them to apply for a permit for changing the face of the sign and were seeking to rectify their non-compliance. Building Officer Moreland informed the Commission that after official approval of the sign, Encore would be required to submit a permit application, pay all fees and penalties. Commissioner Bodkin made a motion to approve the permanent sign face submitted for Encore Memory Care. Commissioner Saller seconded the motion. Tent Structure

Building Officer Moreland reviewed the current submission for a temporary structure to be built in The Arboretum of South Barrington to host holiday events such as Halloween and Christmas. The Commissioners discussed concerns with the structure such as the current proposed location being the former ice rink, ventilation, bathrooms, and landscape. Mr. Moreland indicated that The Arboretum had not submitted a permit for the structure so many of the questions the Commission has would need to be answered prior to issuing a permit. Commissioner McCombie made a motion to approve the temporary structure contingent on the permitting process and the approval of the Village Board. Commissioner Bodkin seconded the motion.
