The structure would be used for seasonal events for the public (no private parties etc.) with the hope of driving traffic to the shopping center. It was explained that the Temporary Structure would not interfere with the current concert series, since it is planned to be installed following the last concert of the year. Glen Hansen representing the company that would install the structure, was asked about ventilation and heating of the structure. Mr. Hansen explained that the plans have been reviewed by the East Dundee Fire Protection District and it will be in compliance. Mitchell Voss was also present representing the Arboretum and he explained the tempered safety glass being used on the structure. Mayor McCombie recognized representation from the East Dundee Fire Protection District to comment on the structure. Fire Inspector Marc Quattrocchi addressed the Village Board and noted that outside of an additional ingress/egress point that is being required, the structure passes their review.
