- Working to change classification of claim on Village Hall roof to wind and hail damage
- Met to discuss the pergolas in Wood Subdivision, might have to approve use of vinyl for roofing but will need to further discuss at upcoming meetings

Village Engineer: Village engineer not present

Chief of Police: Michael Garrison gave a brief report.

- Chief Garrison provided overview on the need for the county cameras and the two sizeable arrests which were apprehended coming from Barrington Hills. The Chief noted that South Barrington department gets alerts from surrounding village's cameras, therefore collaboration with adjoining communities has been successful.
- Part time officer will be starting on 11/19/2024, the officer is full time in Hawthorne Woods
- 3 new officers are currently in field training with 1 new officer close to completing medical screening
