Chairman Rafferty led a detailed discussion on the proposed sign for the outside of the building, including the types of materials that are planned to be used, dimensions of the sign compared to the existing framing left by the previous lessee, and the mechanisms for illumination. Discussion ensued, and Muhammad answered further questions that the Chairman and Commissioners had.

Motion was made by Commissioner Niedzinski, seconded by Commissioner Bodkin to direct staff to take further action, and to postpone the approval of the sign until the next commission meeting for further review. On a roll call vote, the motion was approved unanimously.
