**ANNUAL APPROPRIATION ORDINANCE OF THE
VILLAGE OF SOUTH BARRINGTON
FOR FISCAL YEAR 2025-2026**

Be IT ORDAINED by the President and Board of Trustees of the Village of South Barrington, Cook County, Illinois, that:

SECTION 1. 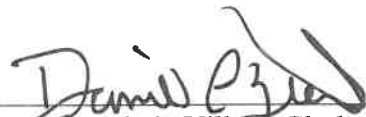
SECTION 3. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
