**NOTICE OF HEARING ON PROPOSED ANNEXATION OF TERRITORY,  
SOUTH BARRINGTON, ILLINOIS**

**NOTICE IS HEREBY GIVEN** that the Plan Commission / Zoning Board of Appeals of the Village of South Barrington, Cook County, Illinois, will hold a public hearing on March 9, 2026 at the South Barrington Village Hall, 30 South Barrington Road, South Barrington, Illinois 60010 commencing at 7:00 pm to consider, make recommendations and conduct a public hearing as required by the applicable statues of the State of Illinois and the Zoning Ordinance of the Village of South Barrington regarding a proposed ordinance authorizing the annexation to the Village of South Barrington, Illinois, certain territory wholly bounded by the Village of South Barrington and a forest preserve district, legally described as follows:

THAT PART OF THE NORTHEAST QUARTER OF SECTION 22, TOWNSHIP 42 NORTH, RANGE 9, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF SAID NORTHEAST QUARTER; THENCE WESTERLY ALONG THE SOUTH LINE OF SAID NORTHEAST QUARTER, 1015.00 FEET; THENCE NORTHERLY ALONG A LINE, A DISTANCE OF 1260.56 FEET TO A POINT ON THE CENTERLINE OF ALGONQUIN ROAD (STATE RTE. 62) THAT IS 1232.0 FEET NORTHWESTERLY OF (MEASURED ALONG SAID CENTERLINE) THE EAST LINE OF SAID NORTHEAST QUARTER; THENCE CONTINUING NORTHERLY ALONG THE LAST DESCRIBED COURSE, TO THE NORTHERLY LINE OF SAID ALGONQUIN ROAD; THENCE SOUTHEASTERLY ALONG SAID NORTHERLY LINE OF ALGONQUIN ROAD, TO THE EASTERLY LINE OF SAID NORTHEAST QUARTER; THENCE SOUTHERLY ALONG THE EASTERLY LINE OF SAID NORTHEAST QUARTER TO THE PLACE OF BEGINNING, IN COOK COUNTY, ILLINOIS.

Pursuant to the South Barrington Village Code, as amended, upon annexation the above described properties shall be zoned A-1 (5 acres) Single-Family Residence District. An accurate map of the subject properties proposed to be annexed to the Village and a copy of the proposed annexation ordinance will be on file with the Village Clerk and may be inspected during regular business hours, Monday through Friday, 8:00 a.m. to 4:00 p.m.

All persons present at the public hearing will be afforded an opportunity to be heard. Written comments may be submitted to the attention of the Plan Commission / Zoning Board of Appeals Chairperson, c/o South Barrington Village Hall at the address aforesaid and will be considered if received at least six (6) hours prior to the hearing. The Plan Commission / Zoning Board of Appeals reserves the right to continue the public hearing from time to time in accordance with the requirements of the Illinois Open Meetings Act.

Individuals with disabilities who plan to attend the hearing and require certain accommodations in order to allow them to observe and participate or who have questions regarding the accessibility of the meeting or facilities are requested to contact the Office of the Village Clerk at 847-381-7510.
