NOTICE OF HEARING TO AMEND ANNEXATION AGREEMENT

NOTICE IS HEREBY GIVEN that the corporate authorities of the Village of South Barrington, Cook County, Illinois, will hold a public hearing on March 12, 2026 at the South Barrington Village Hall, 30 South Barrington Road, South Barrington, Illinois 60010 commencing at 7:00 pm (immediately prior to the Village Board meeting) to consider, make recommendations and conduct a public hearing as required by the applicable statues of the State of Illinois and the Municipal Code of the Village of South Barrington regarding a proposed annexation agreement, legally described as follows:

THE EAST 8 ACRES OF THE WEST 13 ACRES OF THAT PART OF THE NORTHEAST QUARTER OF SECTION TWENTY-TWO, TOWNSHIP FORTY-TWO NORTH, RANGE NINE, EAST OF THE THIRD PRINCIPAL MERIDIAN. WHICH LIES SOUTHWESTERLY OF THE CENTER LINE OF ALGONQUIN ROAD AS DEDICATED JANUARY 30, 1933 AS DOCUMENT NO. 11194095 AND WHICH LIES EAST OF A LINE DRAWN FROM A POINT IN THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION TWENTY-TWO, SAID POINT BEING 1015.0 FT. WEST OF THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION TWENTY-TWO, TO A POINT IN THE CENTER LINE OF ALGONQUIN ROAD, SAID POINT BEING 1232.0 FT. NORTHWESTERLY OF THE EAST LINE OF THE NORTHEAST QUARTER OF SAID SECTION TWENTY-TWO, MEASURED ALONG SAID CENTER LINE MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION TWENTY-TWO, THENCE NORTH 89° 55' 26" WEST, BEING AN ASSUMED BEARING ON THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION TWENTY-TWO A DISTANCE OF 487.94 FT TO THE EAST LINE OF SAID WEST 13 ACRES FOR THE POINT OF BEGINNING, THENCE CONTINUING NORTH 89° 55' 26" WEST ON THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION TWENTY-TWO A DISTANCE OF 344.85 FT. TO THE EAST LINE OF THE WEST 5 ACRES OF SAID WEST 13 ACRES, THENCE NORTH 0° 11' 54" WEST ON SAID EAST LINE A DISTANCE OF 1129.94 FT. TO THE CENTER LINE OF SAID ALGONQUIN ROAD, THENCE SOUTHEASTERLY ALONG SAID CENTER LINE BEING THE ARC OF A CURVE CONCAVE TO THE NORTHEAST HAVING A RADIUS OF 19098.61 FT. AN ARC DISTANCE OF 420.43 FT. WITH A CHORD BEARING OF SOUTH 55° 18' 28" EAST AND A CHORD DISTANCE OF 420.42 FT. TO THE EAST LINE OF SAID WEST 13 ACRES, THENCE SOUTH 0° 11' 54" EAST ON SAID EAST LINE A DISTANCE OF 891.11 FT. TO THE POINT OF BEGINNING, EXCEPTING THEREFROM THAT PORTION OF SAID ALGONQUIN ROAD, ALL IN COOK COUNTY, ILLINOIS.

Written comments may be submitted to the attention of the corporate authorities of the Village of South Barrington, c/o South Barrington Village Hall at the address aforesaid and will be considered if received at least six (6) hours prior to the hearing. The corporate authorities of the Village of South Barrington reserves the right to continue the public hearing from time to time in accordance with the requirements of the Illinois Open Meetings Act.
